HIGH SCHOOL LOYALTY AWARD GUIDELINES (LA)

In addition to the requirements above, MESA members *must* complete the following requirements to be eligible for the Loyalty Award:

- Active membership in MESA for 2 years including first semester of senior year is required for students to receive an award.
- Apply online in March for award after receiving notification if eligible.
- Complete 4 credits of college preparatory math and English and 3 credits of science upon high school graduation.
- Have a minimum ACT score of 18 OR a minimum SAT score of 870 OR a 2.8 weighted GPA
- Have a minimum of 175 points in MIMS
- Submit a schedule of classes from an accredited college or university.
- Provide a brief testimonial of your MESA experiences.
- Provide a social security number, green card number, or tax identification number.

Please note the following:

- Member and parent/guardian agree that NM MESA, Inc. is the final authority on Loyalty Awards.
- Member's grades and test scores are verified by an official high school transcript.
